# DISCUSSION/POSSIBLE ACTION REGARDING VILLA CLAIRE ESTATES

After a brief discussion, Commissioner O'Keefe made a motion to approve a letter to the DNR stating that the Delavan Lake Sanitary District does not object to sewer expansion into the Villa Clare Estates development and to have the

District President, Thomas Miller, sign it. Commissioner Beers seconded the motion which passed unanimously.

# DISCUSSION/POSSIBLE ACTION REGARDING SEWER CONNECTION AT 2214 NORTH SHORE DR.

Attorney Riffle drafted a Final Release of All Claims document regarding the illegal connection at 2214 North Shore Drive. Commissioner Beers made a motion to accept the Final Release of All Claims and Commissioner O'Keefe seconded the motion. After a brief discussion, Commissioner Beers amended his motion to include Attorney Riffle adding additional wording to the first paragraph to clarify the time frame of the violation for the Final Release of All Claims. Commissioner O'Keefe seconded the amended motion and upon vote, the motion passed unanimously.

Specifically, to be discussed is the Board of Adjustment with Walworth County.
