President Miller declared a quorum present for doing business.

After a review of the Regular Meeting minutes of August 23, 2023, Commissioner Beers made a motion to waive the reading of the minutes and approve the August 23, 2023, Regular Meeting minutes as written. Commissioner Kasch seconded the motion which passed unanimously.

FINANCIAL

After a review and discussion of the bills represented by check numbers 28902 through 28950, Allocation of Funds through August 31, 2023, and Financial Statements for periods ending August 31, 2023, Commissioner O'Keefe made a motion to accept payment of bills, Allocation of Funds and Financial Statements as presented. ADMINISTRATOR'S MONTHLY REPORT

In addition to his written monthly report, Administrator DeLuca shared Highway O Road project is almost complete and L.S.#4 project is also coming to an end. Doug is still working on the final designs for L.S.#2A for review before it goes out for bid and he's also working on L.S.#5 to get a final concept ready to go to the County for County zoning approval to rebuild that station.

LAKE COMMITTEE REPORT

Commissioner Beers shared the Lake Committee didn't have a quorum at the last meeting. While the meeting could take place, nothing could be voted on. Mary shared the drone survey of Delavan Lake was completed in order to begin creating a boat count. SEWRPC will be helping to evaluate the results to have a base line to do a carrying capacity study. This study is critical to understanding what the lake can tolerate from a safety standpoint as well as navigation and access. With Lake Lawn's expansion of its property use and 200 more boat slips, looking into the safety profile of the lake is very important.

DISCUSSION/POSSIBLE ACTION - ONGOING LAKE MANAGEMENT

Commissioner O'Keefe shared that he, Adam, and Charlie visited Aquarius to discuss the concern that our barge is too narrow for the large waves on the lake. While Aquarius would like to sell us a new barge, there are no grants available

to offset the cost to the District for a new barge. After a discussion with Aquarius' Engineer and President, Aquarius is putting together a two stage proposal to first add plastic pontoons to the side of the barge and then create and attach aluminum pontoons to the side of the barge to increase the width of it while still keeping it within the measurements for road travel. We are waiting for the proposal to evaluate the cost.
